- 5% Mini-Day Credit** for those enrolled in the **2 & 3 Year Old Mini-Day Programs**, ending daily at 1:00pm. Camp DOES NOT provide transportation home at 1:00pm.

- POST-CAMP: \$500 deposit due on enrollment.** Balance paid in full by July 15, 2020. Post-Camp Deposit and all Post-Camp Payments are fully refundable through July 15, 2020.
